**Supplemental Cash Dividend**

The Bourse and CDCC wish to inform you that the Directors of Teck Resources Limited (the "**Corporation**"), declared on February 21, 2023, a supplemental dividend of CAD \$0.50 per Class B common share. The supplemental dividend will be paid on March 31, 2023 to shareholders of record as of the close of business on March 15, 2023. The ex-dividend date is March 14, 2023.

The declaration of the supplemental dividend is in accordance with the Teck Resources Limited dividend policy and Capital Allocation Framework.
