**FINAL CONTRACT ADJUSTMENT**  
**Resolute Forest Products Inc. (RFP)**  
**Special Cash Dividend**

The Bourse and CDCC wish to inform you that Resolute Forest Products Inc. (the "Company"), declared on June 10, 2021, a special cash dividend of USD \$1.00 per common share. The special dividend will be paid on July 7, 2021 to shareholders of record as of the close of business on June 28, 2021. The ex-dividend date is June 25, 2021.

The Bourse and CDCC will take into account the special dividend by adjusting the deliverable per contract of RFP options, by an amount equivalent to the special dividend that is USD \$100 (\$1.00 x 100).

**CDCC - Adjustment Details:**

According to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Resolute Forest Products Inc. (RFP) options will be adjusted as follows:

- **EFFECTIVE : June 25, 2021**
- **OPTIONS SYMBOL: RFP will become RFP1**
- **NUMBER OF CONTRACTS: Unchanged**
- **MULTIPLIER: Unchanged**
- **DELIVERABLE PER CONTRACT: 100 common shares of RFP and USD \$100**

- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain unchanged at 25 000 contracts.
- **CUSIP:** Unchanged
- **STRIKE PRICES:** Unchanged

**Bourse de Montréal Inc. - Adjustment Details:**

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the change and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.
