ADDITION OF AN INDEX OPTION SYMBOL

Bourse de Montréal Inc. (the Bourse) and Canadian Derivatives Clearing Corporation (CDCC) hereby inform all option participants of the possibility of an upcoming symbol addition for new series of options on the **iShares CDN S&P/TSX Capped Financials Index Fund (XFN)**.

Due to recent price fluctuations of the underlying for XFN and the lack of strike price alpha codes to identify each options series, the Bourse and CDCC will create a new symbol – **XFX** – **for all additional options strike prices of thirty three dollars (\$33.00) and below.**
