The Bourse and CDCC hereby correct the Circular No. 140-12 dated October 29, 2012 and the Notice to Members No.206-12 dated October 29, 2012, regarding the new deliverable according to the plan of arrangement. The cash amount equal to 0.67 common shares of Long Run Exploration Ltd. (“Long Run”) that is included in the new deliverable per GO1 contract has been set at C\$2.69. This cash amount is equal to the closing price of Long Run Exploration Ltd on October 29, 2012 times 0.67. Hence, the new deliverable per GO1 contract is as follows:

- **NEW DELIVERABLE PER CONTRACT:** **41 common shares of Long Run and a cash portion equivalent to 0.67 common shares of Long Run which is equal to C\$2.69**

The cash amount of the deliverable will remain permanently fixed as the option deliverable and will not vary.
