**FINAL CONTRACT ADJUSTMENT

Plan of Arrangement**

The Bourse and CDCC wish to inform you that Baytex Energy Corp. ("Baytex") and Raging River Exploration Inc. ("Raging River") announced on August 21, 2018 that shareholders of Raging River ("Raging River Shareholders") and Baytex ("Baytex Shareholders") have approved their previously announced strategic combination (the "Transaction").

Under the terms of the Transaction, Raging River shareholders will receive 1.36 common shares of Baytex in exchange for each Raging River share owned.

The delisting date for Raging River Exploration Inc. from the Toronto Stock Exchange is at the close of the market on August 27, 2018.
