The Bourse and CDCC wish to inform you that the Board of Directors of Genworth MI Canada Inc. ("**Genworth**" or the "**Company**"), approved on December 4, 2019 a special cash dividend of CAD \$2.32 per common share. The special dividend will be paid on December 30, 2019 to shareholders of record as of the close of business on December 18, 2019. The ex-dividend date is December 17, 2019.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Genworth MI Canada Inc.'s (MIC) options, by an amount equivalent to the special dividend that is CAD \$2.32.

**CDCC - Adjustment Details:**

According to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Genworth MI Canada Inc. (MIC) options will be adjusted as follows:

- **EFFECTIVE DATE: December 17 , 2019**
- **OPTIONS SYMBOL: Unchanged**
- **NUMBER OF CONTRACTS: Unchanged**
- **MULTIPLIER: Unchanged**

- **DELIVERABLE PER CONTRACT:** 100 common shares of MIC
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain 50 000 contracts.
- **CUSIP:** Unchanged
- **STRIKE PRICES:** An adjustment of CAD \$2.32 will be made for all existing series.

**Bourse de Montréal Inc. - Adjustment Details:**

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the change and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.
