iSHARES CDN GOLD SECTOR INDEX FUND ADDITIONAL SYMBOLS FOR LONG TERM EQUITY INDEX OPTIONS

Bourse de Montréal Inc. (the Bourse) and Canadian Derivatives Clearing Corporation (CDCC) hereby inform all option participants of the possibility of additional symbols for new series on long term equity index options on iShares CDN Gold Sector Index Fund (**WDD 2010** and **VXG 2011**).

Due to recent price fluctuations of the underlying for **WDD 2010** and **VXG 2011** and the lack of strike price alpha codes to identify each series, the Bourse and CDCC will create two new long term equity index options symbols – **WXG 2010** and **VGX 2011** – for all additional options strike prices of seven dollars (\$7.00) and below.
